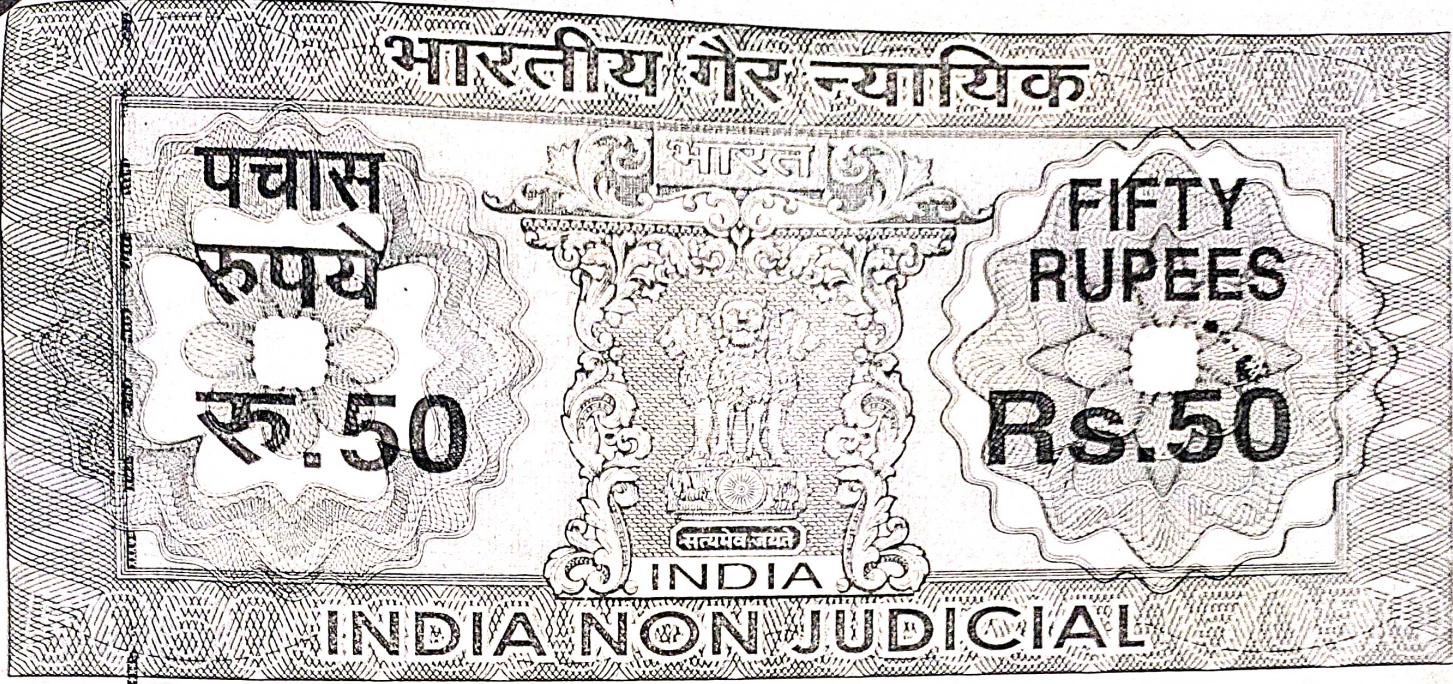

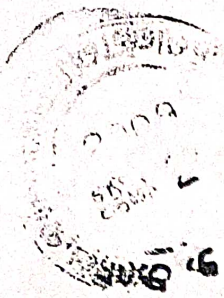
Establishing a fund for the Public Charitable Objects and purposes in India.
